Bostik Glu Tape is a versatile, acid-free, high quality, paper thin, double sided tape with aggressive tack that comes in an easy to use dispenser – so no scissors required. Ideal for non-visible attachment of posters and photos. The double sided tape is an alternative to paper glue.

#### APPLICATIONS

For precise and permanent gluing of paper and photos, this product is ideal for home, office and school work. It can also be used for scrap booking, gift wrapping, sealing of small boxes, labelling of files, art and crafts, handicraft and decorative work and also sticks to ribbon and most materials.

#### ADHESION

Bostik Glu Tape bonds to most materials like paper, card, ribbon, material, foil, glass, metal, wood and plastics.

#### LIMITATIONS

- Not for heavy duty use.
- May damage fragile papers on removal.
- Not suitable where heat resistance is required.

#### SAFETY INSTRUCTIONS

Keep out of reach of small children! Does not contain natural rubber latex.

#### SURFACE PREPARATION

Ensure that surfaces are clean, dry and free of any dust, grease and loose materials.

#### HOW TO USE

1. Flip protective cap open.
2. Press roller down on flat surface and drag the mouse backwards in a straight line.
3. Align the surfaces and gently press together. Once surfaces meet, the tape is not repositionable.
4. Close protective cap when finished.

#### CLEANING

Easily removed from most surfaces non-porous surfaces. Adhesive residue can be removed with acetone.

#### STORAGE STABILITY

The shelf life of the product is 36 months stored at room temperature.
