### PREPARATION

1. The surfaces must be clean, dry and free from any dust or loose material.

### APPLICATION

2. Apply Bostik Tape Discs by peeling from the clear liner and pressing the disc onto the surface. For a more transparent appearance run your fingernail over the disc when on the paper.
3. Be careful not to touch the adhesive side as it might become less sticky.

4. Remaining sheets can be stored in the wallet pack for later use.

#### **CLEANING**

5. Bostik Sticky Tape can be carefully peeled away from a hard surface.

#### **PRECAUTIONS IN USE**

Bostik Tape Discs are unsuitable for use on very absorbent, damp, dusty, delicate or newly decorated surfaces. If in doubt carry out a small test first. Place precisely onto gift

wrap as removal will usually result in the paper tearing. Please be aware that the adhesives get stronger with time so remove with care.
